



Equivalent Circuit








Figure 3. Typical On-Resistance vs. Drain Current and Gate Voltage





Figure 5. Typical On-Resistance vs. Drain Current and Temperature



 $V_{\rm GS}$, GATE-SOURCE VOLTAGE (V) Figure 2. Typical Transfer Characteristic




Figure 4. Typical Transfer Characteristic




Figure 6. On-Resistance Variation with Temperature









Figure 7. On-Resistance Variation with Temperature







T_J, JUNCTION TEMPERATURE (°C) Figure 8. Gate Threshold Variation vs. Junction Temperature




Figure 10. Typical Drain-Source Leakage Current vs.

Voltage




Figure 12. Gate Charge






Figure 13. SOA, Safe Operation Area





Figure 14. Transient Thermal Resistance


