



Fig.1 Grounded emitter propagation characteristics





Fig.2 Typical output characteristics

Fig.3 DC current gain vs. collector current (I)





Fig.4 DC current gain vs. collector current (II)

Fig.5 Collector-emitter saturation voltage vs. collector current (I)




Fig.6 Collector-emitter saturation voltage vs. collector current (II)




Fig.7 Base-emitter saturation voltage vs. collector current






Fig.8 Gain bandwidth product vs. emitter current




Fig.9 Collector output capacitance vs. collector-base voltage Emitter input capacitance vs. Emitter-base voltage
